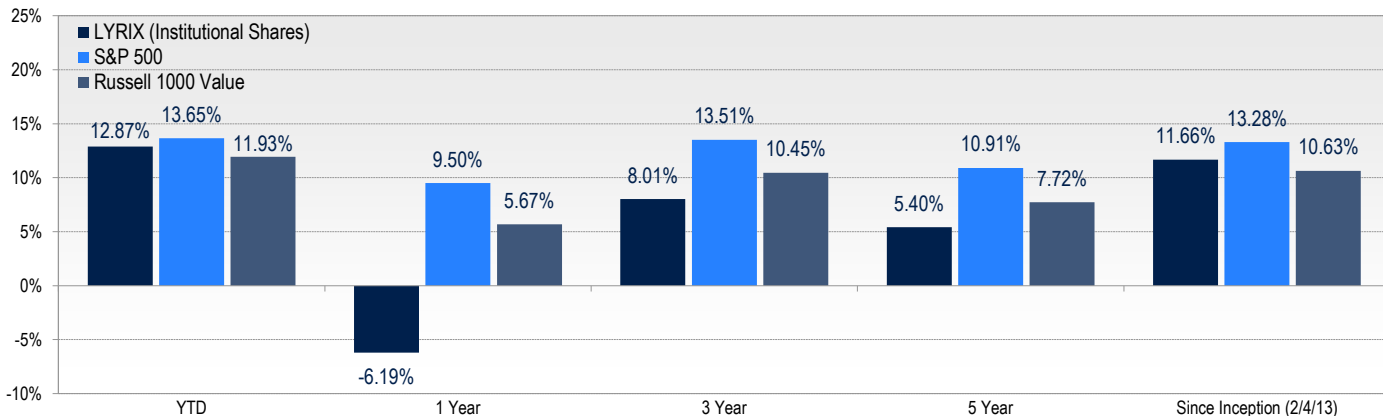


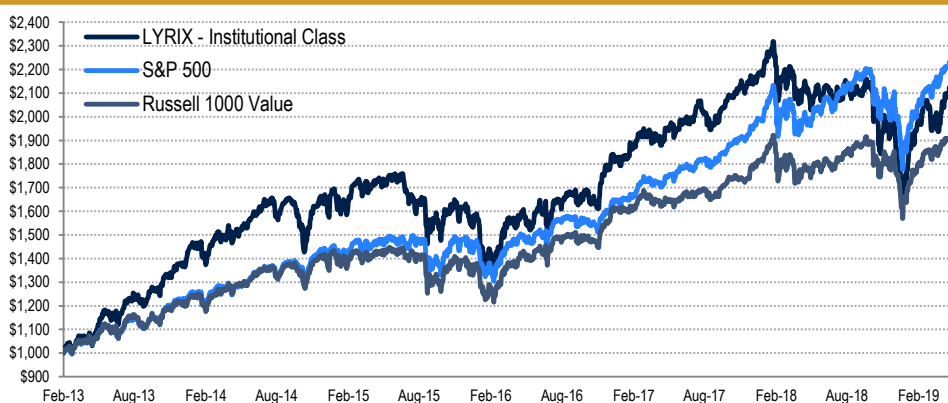

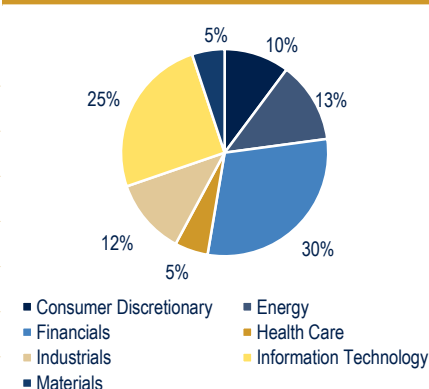

## SUMMARY

Lyrical Asset Management U.S. Value Equity Fund employs a disciplined and repeatable investment process, selecting approximately thirty-three large- and mid-cap companies believed to be both deeply undervalued and quality businesses. Investments are diversified by industry but concentrated enough to drive differentiated performance. Trading is infrequent, and returns are expected to be relatively tax-efficient. The firm was founded in 2008 and is owned by Managing Partners Andrew Wellington and Jeff Keswin.
